

ANNOUNCEMENT OF IMPLEMENTATION RESULTS OF NON-PREEMPTIVE RIGHTS ISSUE ("NPR") PT SURYA ESA PERKASA TBK (The "Company")

Referring to:

It is hereby announced that the Company has implemented NPR, on December 8, 2020 by issuing as many as 1,360,887,000 (one billion three hundred sixty million eight hundred and eighty seven thousand) new shares with a nominal value of Rp. 10 (ten rupiah) per share which is taken by Garibaldi Thohir, PT. Ramaduta Teltaka, Chander Vinod Laroya, Sugito Walujo, Chandru Nebhraj T, Chandru Mahtani, Mukesh Agrawal, Deepak Khullar, Prakash Bumb, Miranda, J.P. Morgan Singapore, Bank Julius Baer, Singapore and UOB Kay Hian Pte. Ltd., Singapore, with an exercise price of Rp. 135 (one hundred thirty five rupiah) per share. The funds received by the Company after deducting the costs related to NPR will be used for investment in subsidiaries and the Company's working capital.

Whereas with the implementation of the said NPR, the total issued and paid-up capital of the Company which was originally 14,300,000,000 (fourteen billion three hundred million) shares will be increased to 15,660,887,000 (fifteen billion six hundred sixty million eight hundred eighty-seven thousand) shares.
