Q	1.	Future prospects of Ammonia dominated by purchases from the Middle East or China?				
	2.	Is the ESSA company as a holding, able to get a large dividend value from the entity or is				
		there any regulation more?				
Α	1.	The sale of ESSA is only to one off taker, Genesis Corporation. But if we look at it from the				
		market side, ammonia sales from Indonesia are usually directed to Korea, Taiwan, Japan				
		and a little bit to China. The biggest purchases are not in the Middle East but to Korea,				
		Taiwan, Japan and beyond.				
	2.	For the matter of dividends, it should probably not be discussed at the time of Pubex. If				
		there is a Corporate action, the Company will be announced separately.

Α	1.	For Revenue and EBITDA this year we can estimate, but in the next year depending on th						
		price of LPG and Ammonia, we expect next year to be high prices. For 2022, our						
		expectations on revenue are greater than 700 million Dollar and EBITDA is greater than						
		330 million Dollar. And for the next year we better not predict, we just see how the market						
		will be next year.						
	2.	a. For ammonia and LPG price trends, it is still higher this year compared to previous years,						
		but for next year we expect the company to remain good.						
		b.For expansion, we are again focusing on the Blue Ammonia project, next year we are						
		still focusing on Blue Ammonia. We are also open to opportunities for other businesses						
		as well, but remain focused on Blue Ammonia in 2023.						
		c. For the new plant ESSA is a progressive group, we are always looking for new projects,						
		but it always depends on the availability of gas sources.

A	1.	For Blue Ammonia, it has been conveyed today about the signing of an MOU on Greenhouse Gas Measurement with JGC Japan. For the production timeline, we can produce in 2025, the capacity is the same as the current capacity. It is not a new Blue Ammonia plant but a conversion from the current Grey Ammonia plant to Blue Ammonia, so the capacity still remains the same.					
	2.	Green Ammonia is a very interesting area, we see on the feasibility side it is still not feasible, but we have to keep monitoring forward. Because as we know in renewable energy, costs can start to drop drastically when many people develop it. This is very interesting, but for now there are no plans to develop Green Ammonia.

	3.	The difference is, in the Blue Ammonia process we take as much CO2 as possible which is					
		currently produced by Grey Ammonia d an CO2 that we enter back into the Earth in the					
		right gas wells (sequester), then the CO2 is not discharged into the air.
